A year of crisis that we would much rather—but must never—forget, 2020 will always be synonymous with the horrific COVID-19 pandemic that sadly continues near the halfway mark of 2021. As of this writing, almost four million Californians have tested positive for the virus, and 62,700 have died.

The toll on workers has been incalculable. Literally. As essential workers continued on the job serving our communities throughout the worst COVID-19 surges, many thousands fell ill and died from the virus. We must never forget those who lost their lives on the job during this grim period in our state's history.

A bright spot during even the darkest days was the labor movement's tireless fight for our members and all workers. Unions forced employers to provide basic personal protective equipment, and the California Labor Federation and affiliates sponsored multiple pieces of legislation to create a COVID-19-specific workers' compensation presumption, improve employer reporting of COVID-19 exposures, and other reforms.

We also fought hard for Executive Orders and immediate new regulatory protections, and guided vaccinations toward the most vulnerable workers. Some unions and Central Labor Councils even distributed vaccines themselves, in a historic effort to maximize our connection with our members to help bring the pandemic to a close.

Many legislators and agency officials also stood with us to make these victories possible. And despite massive corporate opposition to all of these efforts, Governor Newsom often stood with us and stood up to these wealthy special interests. The legislature worked quickly in collaboration with our unions to address the most pressing issues – both health and economic – facing workers over the last year. A record 52 legislators voted 100% of the time in support of working people, a testament to our power as a movement to aggressively defend and expand the basic rights of workers in the legislature.

But, as always, no one deserves more applause than the workers. The sacrifices they've made over the last 15 months offer an undeniable reminder that they are the true heroes, in good times and bad, and they are what keeps this country—and this world—running, no matter the challenges. We are deeply honored to enjoy the privilege of fighting for them and recommit to doing all we can to make sure that their efforts are properly respected, rewarded, and revered.





2020 LABOR SUPPORTED BILLS

1. AB 376 (Stone) – Protect Student Debtors. Makes California the first state in the nation to create a comprehensive set of rights for people holding student debt, by requiring student loan companies to treat borrowers fairly and gives borrowers the right to hold these companies accountable when they fail to meet basic servicing standards.

SIGNED INTO LAW. SENATE: 29-9 (8/28/2020)

2. AB 685 (Reyes) – Employer Reporting of COVID-19 Exposure. Requires employers, within 24 hours of a notification, to tell workers, their unions, and local and state public health agencies of a COVID-19 exposure in the workplace. It also gives the public necessary information to track their own potential exposure, helping to limit the spread of the virus.

SIGNED INTO LAW. ASSEMBLY: 52-24 (8/31/2020) SENATE: 26-12 (8/30/2020)

3. AB 841 (Ting) – Expand Apprenticeships. Mandates using a “skilled and trained” workforce that will immediately support and enhance apprenticeship programs. In addition, this legislation will ensure that transportation electrification infrastructure is installed safely by requiring that at least one electrician be certified by the Electric Vehicle Infrastructure Training Program.

SIGNED INTO LAW. SENATE: 25-14 (8/31/2020)

4. AB 1947 (Kalra) – Strengthen Whistleblower Protections. Strengthens our state’s retaliation laws by extending the filing deadline for retaliation claims from 6 months to 1 year. The bill also allows workers to recover attorney’s fees for whistleblower retaliation claims under Labor Code Section 1102.5.

SIGNED INTO LAW. ASSEMBLY: 46-32 (6/10/2020) SENATE: 28-12 (8/24/2020)

5. AB 1993 (Kamlager) – UI for IHSS. Would have expanded UI eligibility to over 123,000 IHSS providers who care for either their spouse or their child. Currently, these providers are ineligible to receive UI while other providers who care for someone other than their spouse or child are eligible.

VETOED BY THE GOVERNOR. SENATE: 30-0 (8/27/2020)

6. AB 2037 (Wicks) – Hospital Closure Transparency. Significantly improves community knowledge of impending hospital closures.

SIGNED INTO LAW. ASSEMBLY: 50-27 (6/8/2020) SENATE: 25-13 (8/29/2020)

7. AB 2114 (Rodriguez) – UC worker due process. Would have granted resident and intern physicians employed by UC the right to due process before an impartial decision-maker regarding termination of employment or discipline that is non-academic or non-clinical related.

VETOED BY THE GOVERNOR. SENATE: 22-16 (8/29/2020)

8. AB 2234 (Chau) – Improvements to School Personnel Commissions. Makes improvements to school personnel commissions and ensures their right to independent legal counsel. This bill extends existing law by allowing school personnel commissioners to have a role in determining if a conflict of interest exists between the personnel commission and the local school board, entitling them to independent legal counsel.

SIGNED INTO LAW. SENATE: 39-0 (8/28/2020)

9. AB 2537 (Rodriguez) – PPE Stockpile. Requires hospitals to maintain a 3-month stockpile of personal protective equipment (PPE).

SIGNED INTO LAW. ASSEMBLY: 57-20 (6/8/2020) SENATE: 31-7 (8/30/2020)

10. AB 2542 (Kalra) – CA Racial Justice Act. The California Racial Justice Act prohibits racial discrimination in convictions and sentences and creates a process to challenge discrimination at trial or following conviction.

SIGNED INTO LAW. SENATE: 26-13 (8/31/2020)

11. AB 2588 (Kalra) – Paid Training for Health Care Workers. Protects health care workers, before they are technically employees, from becoming liable for employer-required training costs.


SIGNED INTO LAW. ASSEMBLY: 76-1 (6/8/2020) SENATE: 28-11 (8/30/2020)

12. AB 2967 (O’Donnell) – Public Employee Retirement Security. Expressly prohibits employers from amending their contracts to exclude a class of employees from CalPERS coverage that were previously otherwise included.

SIGNED INTO LAW. SENATE: 30-10 (8/24/2020)

13. AB 3216 (Kalra) – Recall and Retention Rights. Would have protected workers in low-wage industries during this—and any future—public health crisis by preventing employers from replacing more experienced workers with newer, lower-paid workers.

VETOED BY THE GOVERNOR. ASSEMBLY: 44-34 (6/18/2020) SENATE: 26-13 (8/30/2020)



2020 ASSEMBLY VOTE SUMMARY

14. AB 3262 (Stone) – Electronic Retailer Accountability. Would have held online marketplaces, such as Amazon, to the same legal standard as traditional brick and mortar businesses for when consumers who are injured may obtain compensation for their injuries.

HELD IN SENATE. ASSEMBLY: 54-24 (6/11/2020)

15. ACA 5 (Weber) – Racial Equity in Hiring. Would have allowed public entities to consider race, sex, color, ethnicity, or national origin in the operation of public employment, education, or contracting, if approved by voters (Proposition 16).

APPROVED BY LEGISLATURE, REJECTED BY VOTERS. SENATE: 30-10 (6/24/2020)

16. SB 275 (Pan) – PPE for Health Care Workers. Requires health care employers to stockpile personal protective equipment (PPE) for use in the event of a declared state of emergency.

SIGNED INTO LAW. ASSEMBLY: 66-10 (8/31/2020)

17. SB 1044 (Allen) – Protect Firefighters from Harmful Chemicals. Phases out the use of harmful firefighting foam-containing PFAS chemicals, with some time limited exceptions, and requires notification of the presence of intentionally added PFAS in the personal protective equipment of firefighters.

SIGNED INTO LAW. ASSEMBLY: 72-2 (8/26/2020) SENATE: 38-2 (6/26/2020)

18. SB 1173 (Durazo) – Public Sector Organizing. Would have established accountability measures, with employer cure periods, to help ensure public employers are properly adhering to the information requirements in current law around public sector worker organizing.

HELD IN ASSEMBLY. ASSEMBLY: 55-21 (8/31/2020) SENATE: 21-19 (6/25/2020)

19. SB 1383 (Jackson) – Paid Family Leave Job Protection at Small Businesses. Prohibits employers with more than five employees from firing workers who take time off when family needs arise. (Prior law allowed employers with fewer than 20 employees to terminate those who claimed baby bonding leave, and the threshold for other family leave was 50 employees.)

SIGNED INTO LAW. ASSEMBLY: 46-30 (8/31/2020) SENATE: 21-17 (7/2/2020)
